## **Applications/Limitations**

The compliance is valid provided the following conditions are observed:

- 2. The composition of the actual upholstered piece of furniture must be the same as the one tested.

Moreover according to Directive 2014/90/EU, Annex II Paragraph 3, a project examination and a risk evaluation have been carried out. Concerning this aspect, the Sponsor has declared that the applicable standard cover all the reasonable risk that can be foreseen. This Notified Body maintains such a declaration in the files relative to the product object of this EC Type Examination.

It is reminded that the present document refers to hypothesis of upholstered furniture, obtained coupling the leather supplied by the Sponsor with the foam supplied by the Laboratory.

In case the filling materials is changed from the one used for this examination, the test shall be repeated with the actual combination used.
